- In business for a minimum of 12 months (prior to April 15, 2022)
- Is headquartered in Palm Beach County

### A company may be considered for this award if they are:

1. **Self-Nominated** – A company may nominate themselves and ***MUST*** submit a letter of recommendation along with the completed application.
2. **Nominated By A Third Party** – One may nominate another company, simply by filling out the application.
